1. Introduction

3. Information We Collect & How We Use Your Information

We may collect and use the following types of personal information about you:

Contact details: Your name, postal address, email address, telephone number, and company details (if applicable).

Identity verification information: At least one form of photographic identification (such as a passport, driving licence, or national identification card) and one document providing proof of residence (such as a recent utility bill).

Nationality and immigration information: Your nationality, immigration status, and information from related documents (e.g., passport, visa, or residency permit), particularly if you are a potential tenant applying for a tenancy.

Anti-Money Laundering (AML) and Counter-Terrorist Financing checks: Information required to enable us to conduct electronic AML and compliance checks in accordance with legal requirements.

Property preferences and requirements: Information relating to the property you wish to buy or rent through our services. This may include details that allow us to send you suitable property listings and updates to assist with your search.

4. Securing Your Personal Information

The security of your personal information is important to us. We implement appropriate technical and organisational measures to protect your information against unauthorised access, loss, misuse, disclosure, alteration, or destruction. These measures include secure servers, firewalls, encryption, and restricted access to personal data.

However, while we take all reasonable precautions to safeguard your information, no method of transmission over the Internet or electronic storage is completely secure. Therefore, we cannot guarantee absolute security. Any transmission of personal information is at your own risk.

5. Marketing Communications

- Right to lodge a complaint to raise a complaint with a data protection authority, such as the Information Commissioner's Office (ICO) in the UK, if you believe your rights have been infringed.
